NEW BUSINESS:

BILL # 13 - ORDINANCE – GRANTING UNTO DUQUESNE LIGHT COMPANY TWO RIGHTS OF WAY ALONG SYCAMORE DRIVE IN ORDER TO PROVIDE ELECTRICAL POWER FACILITIES IN AND AROUND SAID ROADWAY.

BILL # 14 - ORDINANCE – AN ORDINANCE OF THE CITY OF MCKEESPORT, ALLEGHENY COUNTY, PENNSYLVANIA, RELATIVE TO THE ESTABLISHMENT AND MAINTENANCE OF THE MUNICIPAL FIREFIGHTER'S PENSION, ANNUITY, INSURANCE AND BENEFIT FUND OR FUNDS, TO AMEND CERTAIN PROVISIONS OF THE DEFERRED RETIREMENT OPTION PROGRAM (DROP) TO CONFORM WITH THE CURRENT COLLECTIVE BARGANING AGREEMENT.

BILL # 15 - ORDINANCE – AN ORDINANCE OF THE CITY OF MCKEESPORT, ALLEGHENY COUNTY, PENNSYLVANIA, RELATIVE TO THE ESTABLISHMENT AND MAINTENANCE OF THE MUNICIPAL POLICE PENSION, ANNUITY, INSURANCE AND BENEFIT FUND OR FUNDS, TO AMEND CERTAIN PROVISIONS OF THE DEFERRED RETIREMENT OPTION PROGRAM (DROP) TO CONFORM WITH THE CURRENT COLLECTIVE BARGANING AGREEMENT.

BILL # 16 - RESOLUTION - AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE ALL DOCUMENTS NECESSARY TO EXECUTE AND ACCEPT THE ATTACHED GRANT AGREEMENT WITH THE REDEVELOPMENT AUTHORITY OF ALLEGHENY COUNTY IN RELATION TO THE ACTIVE ALLEGHENY GRANT AWARDED TO THE CITY OF MCKEESPORT – INCREASING THE AMOUNT FROM EIGHTY-ONE THOUSAND (\$81,000.00) DOLLARS (FY-2020) TO TWO HUNDRED FORTY-ONE THOUSAND (\$241,000) DOLLARS (EXTENDED INTO FY-2024).

BILL # 17 - RESOLUTION - OF THE CITY OF MCKEESPORT, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING THE PROPER CITY OFFICIALS TO EXTEND THE CITY'S AGREEMENT WITH ENVIRONMENTAL PLANNING & DESIGN, LLC, IN THE AMOUNT OF ONE HUNDRED SIXTY THOUSAND (\$160,000.00) DOLLARS FOR A TWELVE (12) MONTH PLANNING PHASE FOR PROJECTS RELATED TO PUBLIC ACCESS TO MCKEESPORT WALKING AND BICYCLE TRAILS.

BILL # 18 - RESOLUTION - APPROVING A SUBDIVISION REQUEST FROM JOHN SCOTT DBA LIL DEMON ENTERPRISES, LLC TO SUBDIVIDE ONE (1) PARCEL AT 2511 GRANDVIEW AVENUE (LOT & BLOCK 464-D-285) INTO TWO (2) PARCELS. THE PROPERTY EXISTS IN A R-3 ZONING DISTRICT.

BILL # 19 - RESOLUTION - PROVIDING FOR THE APPOINTMENT OF A MEMBER TO THE MCKEESPORT ZONING HEARING BOARD OF ADJUSTMENTS.

BILL # 20 - RESOLUTION - AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE ALL DOCUMENTS NECESSARY TO ENTER INTO AN AGREEMENT WITH KUCICH CONSTRUCTION COMPANY IN AN AMOUNT NOT TO EXCEED \$700,000 FOR THE RECONSTRUCTION OF THE LYSLE BOULEVARD GARAGE UTILIZING A PORTION OF A PENNDOT MULTI-MODAL TRANSPORTATION FUND GRANT AWARDED TO THE CITY OF MCKEESPORT.
